NOTES

- 1. The SAFRA-SIM GLOBAL EDUCATION Scheme is open to all SAFRA <u>Ordinary A</u> (except NSFs), <u>Ordinary B</u> and <u>Life</u> members who can fulfill the basic SIM admission criteria.
- 2. There is no bond attached to the Scheme.
- 3. False particulars or wilful suppression of material facts will render you liable to disqualification, or, if awarded, to revocation of and/or appropriate legal proceedings.
- 4. SIM does not enter into correspondence with regard to the reasons for non-selection of candidates.
- 5. University graduates are <u>not</u> eligible to apply for the Scheme.
- 6. The Sponsorship is open to new incoming students pursuing a SIM diploma programme in SIM Global Education.
- 7. Applicants will be assessed according to their length of SAFRA membership, participation in SAFRA events/activity clubs, academic performance and working experience.
- 8. Applicants are allowed to apply for only one course under the Scheme for each intake.
- 9. Copy of the original pay-slip or letter from the employer must be attached for each working family member, including the applicant. Where pay-slip is not available, a printed statement of CPF contribution for one year is to be included. Family members who are not working (excluding applicant) must have CPF contribution statement for a year and a letter of declaration.
- 10. Certification of supporting documents is to be made by your company. In such cases, state the name, designation, NRIC no. and contact number and email of the person certifying the documents.
- 11. Priority will be given to applicant's combined monthly household income of less than \$3,000.
- 12. Short-listed candidates will be required to attend one or more interview sessions.
- 13. The term will commence in the intake selected by applicants. No deferment is allowed.
- 14. Applications must be submitted on or by <u>30 September 2025</u>.
- 15. The completed SIM application form (and all necessary supporting documents) must be submitted through and endorsed by SAFRA.
- 16. Should the sponsoring institution cease to operate or end its agreement with SAFRA, SAFRA shall not be liable to see through the completion of the sponsored candidates' courses.
- 17. The decision of both SAFRA and SIM Global Education is final and no further correspondence will be entertained.
